TERMS OF AGREEMENT: RDP Productions will provide quality, professional service with integrity at all times. As always we strive for excellence. However, if you are not satisfied with the quality of service rendered, please bring it to the attention of the owner. Adjustments will be made as needed.

Please initial below by each term.

_____ In the event of an emergency (accident, illness, or death) concerning either party, this contract will become null and void.

_____ RDP Productions retains all rights to the images for demo purposes (website advertising and social media).

_____ In the event of inclement weather (rain or snow), RDP Productions reserves the rights not to shoot outdoors unless there is shelter to protect our equipment. Otherwise, this contract will be null and void.

_____ If your event exceeds the allotted time, RDP Productions reserves the right to cease services without explanation. However, additional charges for extra photography time shall be charged at \$150.00 per hour. The balance must be paid in full before receiving final product.

_____ The Client agrees to pay for the photographer's travel, food, beverage and lodging cost (if required). Mileage will be added if the venue is more than 10 miles from our location.

_____ The Client agrees to provide food and beverage to the photographer during the event with an allotted time of 30 minutes for consumption.

_____ The Photographer shall not be held responsible for any photography coverage requested as a result from the late arrival or lack of performance by the designated event coordinator, as appointed by the Client, if one is appointed.

_____ Also, if the event is cancelled or postponed, RDP Productions does not assume any responsibility. However, we will accommodate any date change if we are available. Any changes must be in writing via e-mail. The only way to add or change this agreement is to do so in writing, signed by all the parties.

_____ If the lightning is low during the event, we would recommend that the lights be brighter so that the camera focus can work properly. However, if you choose to create an ambiance by dimming the lights, your images may have some dark areas.

_____ Upon final payment by the client, the client has **limited copyright ownership** of the resulting images. The images may be used only for personal use and may not be copied, or reprinted without express permission of RDP Productions. The Client must obtain written permission from, and compensate RDP Productions prior to the CLIENT, or its friends/ relatives publishing or selling the images for profit.

SCHEDULE OF PAYMENTS: One third of the total balance is due to secure the client's requested date. \$200.00 of this payment is **non-refundable** . Please make check payable to **RDP Productions**.

_____ The remaining balance must be paid in full with a cash payment five days before the event.
